### Australian Fish Names Standard

The Australian Fish Names Standard (AS 5300) provides guidance on complying with requirements for the use of standard fish names in Australia, and is intended for use by people and businesses involved with fish or seafood in Australia.

Seafood Services Australia (SSA) accepted responsibility for standardising fish names in 2001. The Fisheries Research & Development Corporation was accredited as a Standards Development Organisation in 2013 and continued this responsibility



### Australian Fish Names Standard

A Fish Names Committee is responsible for the development and maintenance of this Standard, which is underpinned by rigorous policies and procedures that have been developed by FRDC.

The Committee, which meets twice a year, comprises representatives from the following industry sectors: harvesting, production, retail and hospitality; representatives from academia; a recreational fishing representative; and an independent Chair.



# Need for standard fish names

Adoption of the Fish Names Standard will assist with consistent legislation and policy across Australia. Standard fish names will:

- 1. Improve management of food safety
- 2. Remove confusion when identifying fish by recreational fishers and others
- 3. Strengthen recreational fisher and consumer confidence for target species





- 4. Create market efficiency in the commercial and recreational fishing sectors
- 5. Facilitate product recall and traceability
- 6. Underpin effective species-based fisheries management
- 7. Improve management of food safety.





The use of the Fish Names Standard achieves outcomes that are consistent with the aims of industry and governments:

- 1. Improved monitoring and stock assessment enhances the sustainability of fisheries resources
- 2. Increased efficiency in marketing and promotion improves consumer confidence, industry effectiveness and industry value



#### Purpose of the Fish Names Standard

- 3. Improved accuracy in descriptions enables fishers/consumers to make better informed choices when targeting species for recreational purposes or purchasing seafood for consumption
- 4. Seafood-related public health incidents and food safety risks can be more efficiently managed through improved labelling and species identification
- 5. Marketability and consumer acceptability of species are enhanced through the use of standard fish names.

TROPICAL SNAPPERS (*Lutjanus* spp.) [Capitals signify group names covering more than one species]


Snapper (*Chrysophrys auratus*)

Australia has more than 5,000 native species of finfish, and many more crustaceans, molluscs and other invertebrates. The Australian Fish Names Standard now includes agreed names for nearly 5,000 Australian and imported Standard Fish Names.






### State/Territory overlap of recreational and commercially important fish species with snapper in their Standard Name











