The FRDC Australasian Scientific Conference on Aquatic Animal Health & Biosecurity is a biennial event that first occurred around 1999 and has run continuously since then (except for 2021 due to COVID).

The sixth Conference in 2023 attracted 90 participants, 4 keynote speakers, an industry panel session and 50 aquatic animal health and biosecurity presentations.

In 2024, the AAHBCP committee commenced planning the seventh conference, which will be held in Cairns from 8 - 11 July 2025.

# Seventh FRDC Australasian Scientific Conference on Aquatic Animal Health & Biosecurity

Date: 8-11 July 2025 Venue: Pullman Reef Hotel, Cairns, Australia

Sponsored by the Fisheries Research & Development Corporation (FRDC) and delivered through the Aquatic Animal Health and Biosecurity Coordination Program (AAHBCP), the conference is the premier event for the aquatic animal health community in Australia, bringing together researchers, industry, government, and students. Emerging researchers in the field are encouraged to present their work, with a prize for the best PhD student presentation. The conversations that occur at this event are also an invaluable opportunity to foster collaboration.

The Seventh FRDC Australasian Scientific Conference on Aquatic Animal Health and Biosecurity will be held at the Pullman Reef Hotel, Cairns, starting at 9:00am on Tuesday 8 July and closing at midday on Friday 11 July 2025. The conference dinner will be held on Thursday 10 July 2025. The dates, timing and venue were determined based on feedback from previous conferences. Please note there is no longer a free afternoon on Wednesday as we have made the close earlier on Friday to make it easier for people to get home for the weekend. Wednesday was always a good opportunity for informal and formal meetings, so these can be held on Friday afternoon.

This year the theme of the conference is **"Technology for Improved Production and Health."** The conference program will be developed based on the range of topics received as abstracts, and all topics relating to aquatic animal health and biosecurity are welcome. At least one panel session will take place and is currently being organised.
