Sean Sloan has over 25 years of experience in natural resources management, fisheries and aquaculture management, research, monitoring, assessment and industry development, and more recently forestry.

Sean has held senior fisheries positions in the Commonwealth and State Governments of Australia and at the Pacific Islands Forum Fisheries Agency based in the Solomon Islands, involving management, research, assessment and development of fisheries and aquaculture resources.

Sean joins FRDC from the New South Wales Department of Primary Industries and Regional Development, where he is the Deputy Secretary for the Fisheries and Forestry portfolio.
