Fishery industry leaders

The Australian Rural Leadership Foundation (ARLF) has, since 1992, developed and delivered leadership programs that make a difference to individuals, organisations and communities that have a commitment to rural, regional and remote Australia. Since 1992, the Fisheries Research & Development Corporation (FRDC) has funded the participation of industry leaders in ARLF education programs to support ongoing industry involvement, development and innovation.

The ARLF's educational programs have evolved over time in response to leadership education research. The Foundation's programs have, however, always been based upon the offering of diverse experiences and critical reflection sessions. These are the two processes that shape leadership learning. The experiences and critical thinking processes provide the framework within which the Foundation's identified leadership principles are presented to participants.

The ARLF's eight leadership principles are:

- 1. Contextually and culturally responsible
- 2. Understanding self (relative to and respectful of others)
- 3. Ethically based
- 4. Effective and constructive
- 5. Facilitates change
- 6. Recognises and responds to complexity
- 7. Values difference
- 8. Works with others

The Foundation's commitment to ARLP and short course graduates is continued through their membership of the LEAD Network. It provides networking and life-long professional and personal development opportunities for all Foundation graduates.

To gauge the success of programs is difficult due to the individualised nature of our leadership education. However, the ARLF believes that the best indicator of success is evidenced through the work of graduates.

This report, focusing on the fishing industry, demonstrates this success by showcasing the contribution of 46 Foundation graduates and current participants sponsored by FRDC and four other graduates who were sponsored by other industries and organisations, but who work in the fishing industry. These other industries and organisations are:

- 1. Woolworths; sponsored Bradley Warren to participate in ARLP Course 18 in 2011-2012.
- 2. Sydney Fish Market; sponsored Grahame Turk to participate in TRAILblazers 2010.
- 3. Ellen Cameron; sponsored by the Oyster Farmers' Association to participate in TRAIL 2012.
- 4. Kenneth Bedford; sponsored by the Torres Strait Regional Authority to participate in ARLP Course 20.

To classify the areas of industry involvement of the 50 Australian Rural Leadership Foundation graduates and course participants identified in this report is somewhat difficult as the vast majority are involved in the industry at a number of different levels and through various associations, groups and organisations. However, for the purpose of this report the main industry involvement of each participant is identified in the following chart.




Chart 1: ARLF participant/graduate work sector

The majority of participants/graduates are involved in commercial fishing (17), with eight involved predominantly in seafood/fishing industry representative organisations. Of the participants funded by the Fisheries Research & Development Corporation (46), five have moved to other unrelated industries and one is deceased.

The 50 Foundation graduates and course participants funded by the FRDC or involved in the industry come from jurisdictions throughout Australia, with the highest representation being Western Australia (10), and the lowest, the Northern Territory (2).




Chart 2: Participant/graduate jurisdiction. Note: "other" accounts for one participant working in PNG and one deceased graduate

The majority of FRDC funding has been for participant sponsorship on the Australian Rural Leadership Foundation's flagship educational program, the Australian Rural Leadership Program. Two ARLP graduates/participants have/are engaged in both ARLP and TRAIL*blazers*; and four graduates completed TRAIL*blazers* only.




Chart 3: FRDC funded participant/graduate program

A characteristic of the leaders described in this report is their propensity to take on additional work within the industry and with other organisations that contribute to industry or community resilience. Due to the plethora of involvement within these additional industry and community organisations, it is difficult to draw an accurate depiction of the number of groups and organisations that individuals have engaged with, although the antecedents provided for each of the Foundation graduates provides a clear indication of high level involvement.

Additionally, feedback from participants indicates that participants/graduates dedicate, on average, 16.3 hours per month to voluntary work. This far exceeds the average contribution of Australians of approximately 10.7 hours per month as indicated in ABS statistics from the 2014 General Social Survey¹.

The short profiles provided for each of the ARLF graduates/participants following, demonstrates the significant ongoing contribution of these individuals to their industry and to Australia more broadly.

Ashby, Crispian

ARLP 14 (2007-2008)

Sponsored by: Fisheries Research & Development Corporation

Crispian is the Programs Manager at Fisheries Research and Development Corporation. This role involves investing in and managing research and development projects that will benefit all stakeholders of Australian fisheries and realise the FRDC's vision and mission.

He is a fisheries ecologist with over 15 years of experience in the study and management of aquatic natural resources throughout Australia and internationally. As Senior Fisheries Manager with NSW Department of Primary Industries, Matt manages research funded under the Invasive Animals CRC exploring the control of pest fish species Common carp through biological control. Matt is also director of small consulting firm, Greenfish Consulting Pty Ltd, and of the not for profit organisation, OzFish Unlimited, which aims to work with community groups to improve waterway health through aquatic habitat restoration.

Matt has led the successful delivery of a variety of projects developing cost effective solutions to enable clients to minimise avoidable impacts on marine systems. Examples include an innovative monitoring program in the Gulf of Carpentaria to ensure sustainable interactions between prawn fisher key threatened marine species. Matt has also helped deliver research in southern Laos utilising behaviour of resident fish species for enhancing fish passage past barriers in the lower Mekong catchment. Matt's knowledge of fish behaviour has also been helpful in exploring technological innovations to reduce capture of non-marketable tropical marine fish species in commercial fisheries.

At the time of completion of the Australian Rural Leadership Program, Martin was Chief Executive Officer of the Australian Prawn Farmers Association. Stephen is a member of the Board of the Australian Maritime and Fisheries Academy (AMFA). AMFA delivers maritime, fishing and seafood industry-specific development and education programs. AMFA also facilitates industry-based traineeships that are specifically focussed on providing opportunities to people wanting a career in commercial fishing, aquaculture, seafood processing, seafood retailing and maritime industries.

Stephen is still involved in many fishing businesses including mackerel and fin fish in the north west of WA and the NT, and charter boats in NT and belongs to the relevant associations that represent those interests. He spends a lot of time trying to improve the product in respect to the quality and marketability.

Horn, Felicity

Felicity Horn is Executive Officer of the Shark Bay Prawn Trawler Operators' Association.

In 2001, Felicity started working for the WA Fishing Industry Council (WAFIC) in their Resource Access area after completing an aquatic science degree at Curtin University. In this role she worked with fishermen on their access to marine parks, sustainability and bycatch issues and resolving access issues with other user groups. However, Felicity grew up in a commercial fishing family in Dongara, a small fishing town north of Perth, so being a part of the industry has always been second nature to her. She has been Executive Officer of the Shark Bay Prawn Trawler Operators' Association (SBPTOA), which represents the Shark Bay Prawn Fishery since February 2016.

Jarrett, Annie

TRAILblazers 2011

Sponsored by: Fisheries Research & Development Corporation

The Northern Prawn Fishery (NPF) is Australia's largest, most remote and most valuable wild caught prawn fishery, covering an area of approximately 770 000 square kilometres from Cape York in North Queensland to Cape Londonderry, Western Australia.

The industry has embarked on a process to have the sustainability of the area recognised through Marine Stewardship Council (MSC) certification, which is based on the Forestry Stewardship Council (FSC) model. The MSC standard examines the sustainability of the target stocks, the environmental impact of fishing operations and the management and governance systems that are in place, and is considered by many to be the global gold standard of fishery sustainability certification programs.

2011 Trailblazer participant, Annie Jarrett, is the CEO of the Northern Prawn Fishery Industry Pty Ltd, the company that represents the northern prawn fishing industry; she is keen to have the fishery's sustainability credentials recognised globally. This was achieved – the NPF was MSC certified in 2012, and they are now going through the recertification process.

Jenkins, Helen

ARLP C23 (2016-2017)

Sponsored by: Fisheries Research & Development Corporation

Helen has spent the majority of her working life in small regional towns and has spent the last 28 years working in the seafood industry. She is currently the Executive Officer of the Australian Pawn Farmers Association and has been a business manager for a Japanese owned seafood company.

Helen has recently accepted a new position and in July will take on the new role of Aquatic Industry Liaison Officer, Northern Australia.

Kennedy, Tom

ARLP 14 (2007-2008)

Sponsored by: Fisheries Research & Development Corporation

Tom had been farming with his father Frank at their Big Bay lease since moving back to Tasmania's North-West in 2002, after the completion of a Bachelor of Aquaculture in Launceston at the University of Tasmania. On July 1 2014, Tom, who had been managing director of Shipwreck Oysters, the family business his father started with one 15-hectare farm in 1978, was ready to start his own business with his wife.

Shipwreck Oysters over the years expanded to include 53-hectares in Big Bay. In recent years they also expanded to include a five- hectare plot at Pittwater near Hobart to finish off its oysters. Tom's business, Pirate Point Oysters now runs the 53-hectare lease in Big Bay. The farm grows around four million 3-4mm Pacific oyster spat to 55mm, which takes about 18 months.

Tom's father Frank, who continues to manage Shipwreck Oysters, finishes the Pirate Point Oysters at the fivehectare lease at Pittwater.

Pirate Point Oysters also on-sell their juvenile stock for finishing at three other large farms in Tasmania. Wanting to offer a paddock to plate experience, Tom and his partner opened Pirate Point Oyster Bar in Stanley on 24 January 2014 but the bar has since closed.

Knuckey, Ian

The Director of Fishwell Consulting, Dr Ian Knuckey provides expert research advice and consulting services to encourage and promote sustainable fishing practices to the commercial fishing industry within Australia.
